- Performs major and general mechanical repairs to SYSCO vehicles and reefer units including trouble shooting mechanical problems and identifying their solution in an effort to correct malfunctions and reduce further breakdowns.
- Follows PM schedules on all equipment.
- Completes repair of vehicles in accordance with DOT and State laws.
- Maintains accurate records of each repair performed on SYSCO vehicles.
- Maintains shop area by keeping tools and equipment picked up; cleaning up liquid spills; sweeping floor; dumping trash, and performing other related duties.
